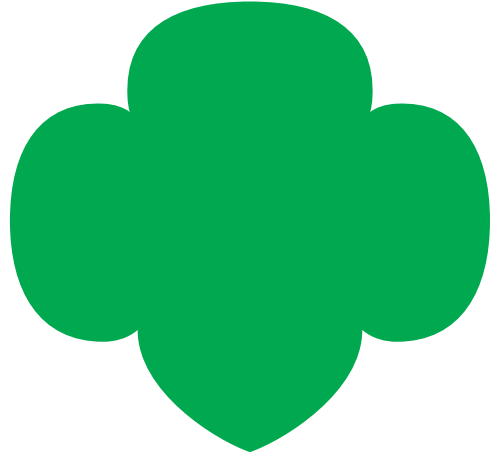

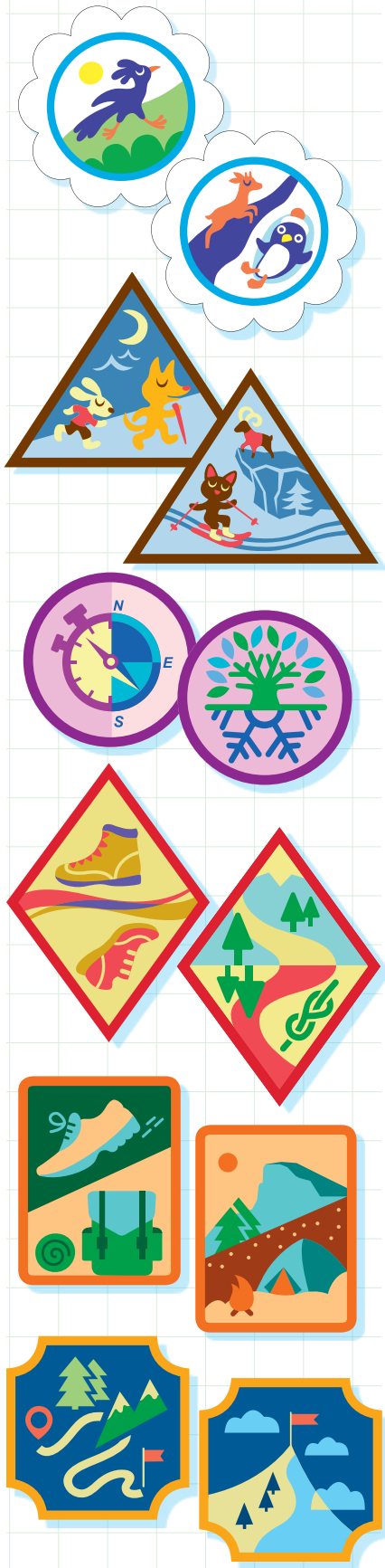

# G.I.R.L. 2017—A GLOBAL GATHERING FOR EVERY GIRL

Where else can thousands of go-getters, innovators, risk-takers, and leaders gather to spark change and make the world a better place?

From dive tanks to infinity rooms to inspirational speakers (and more!), **G.I.R.L. 2017** truly was an epic event—and the LARGEST girl-led event in the world! Hosted by Girl Scouts of the USA, G.I.R.L. 2017 took place in Columbus, Ohio, October 6–8, providing every G.I.R.L. (Go-getter, Innovator, Risk-taker, Leader)<sup>™</sup> with unforgettable experiences as she got inspired, gained tools to empower herself, and learned how to lead change in her community, all while connecting with some of the most influential women in the world along the way.

And the best part? G.I.R.L. 2017 was 100% girl-led! That's right! Twenty-one girls from across the Girl Scout organization, nicknamed the G-TEAM

(girls together empowering and mobilizing), made up the core of G.I.R.L. 2017's planning efforts to ensure this national Girl Scout convention was the best one yet!

And before G.I.R.L. 2017 kicked off, hundreds of Girl Scout

delegates—girl and adult members of Girl Scouts—traveled to Columbus from around the country to represent their councils and Girl Scouts at large at the **54th National Council Session**. At this triennial meeting, delegates influence the strategic direction of the organization by providing guidance to

the Girl Scouts of the USA Board of Directors, in the form of, for example, electing new board members and amending the Girl Scout Constitution.

Accomplished public figures Chelsea Clinton, Gabby Douglas, Barbara Pierce Bush, Mae Jemison, and many others joined G.I.R.L. 2017 throughout the weekend, leading panels and intimate breakout sessions on the pressing issues facing girls today. The event also featured performances by talented young artists, such as Angelica Hale and Caly Bevier from America's Got Talent.

The **Hall of Experiences** was one of the biggest (literally!) attractions at G.I.R.L. 2017, offering more than ten unique hands-on activities focused on Girl Scouts' national program pillars of science, technology, engineering, and math (STEM); entrepreneurship; life skills; and the outdoors. Here girls also had an opportunity to make an impact both locally and globally by taking part in the Rise Against Hunger service project. For the project, girls packed a whopping 20,768 meals for people in need—in Columbus and beyond. Dianne Belk, Founding Chair of the Juliette Gordon Low Society, spoke and 218 individuals made planned gift commitments.

Where else can thousands of go-getters, innovators, risk-takers, and leaders gather to spark change and make the world a better place? Girl Scouts, of course!



# GIRL SCOUTS' NATIONAL YOUNG WOMEN OF DISTINCTION HONORED

The 2017 National Young Women of Distinction—the top Gold Award Girl Scouts of the year—were recognized at G.I.R.L. 2017 for their remarkable leadership and excellence at creating

positive change in their communities and beyond. On October 7, the 2017 National Young Women of Distinction (NYWOD) joined Chelsea Clinton for lunch, where they discussed their Gold Award projects and their personal journeys. Later, all ten Gold Award Girl Scouts joined Chelsea for a roundtable discussion about ways girls can take action in their own communities and change the world.

From the thousands of exceptional, newly minted Gold Award Girl Scouts each year, GSUSA recognizes ten girls as inspiring leaders who have transformed an idea and vision for change into an actionable plan with measurable, sustainable, and far-reaching impact at the local, national, and global levels. Susan Bulkeley Butler and the Kappa Delta Foundation provided a combined \$15,000 scholarship to each of the 10 young women.

From supporting menstrual hygiene for girls in rural India to creating water conservation technology to help farmers in California, this year's National Young Women of Distinction have addressed some of society's most pressing issues in big ways. They exemplify how Girl Scouts confidently stand up for what they believe in and take action to solve community problems—making the world a better place.

When it was my turn to talk to Chelsea, I told her about my Gold Award project, which earned me the National Young Woman of Distinction honor . . . One point that really stood out from the conversation was that girls can be passionate about a cause that matters at any age; they don't need to be adults. There are ways to help no matter how big or small someone is.

The Girl Scout Gold Award is the most prestigious award in the world for girls (and the most difficult to earn), and it's available exclusively to Girl Scouts. Gold Award Girl Scouts are inspiring leaders who are working on a broad range of the most challenging problems facing our world today—from human trafficking to ocean pollution to education access to expanded STEM training for girls in underserved communities.

Gold Award Girl Scouts rate their general success significantly higher than their peers and report greater success in reaching their goals in many areas. Gold Award Girl Scouts also have a competitive edge in the college admissions process, are eligible for college scholarships, and enter the military one rank higher.



# GIRL SCOUTS INTRODUCES 30 NEW BADGES TO ELEVATE GIRLS' LEADERSHIP

Enhancing Girl Scouts' proven girl-led programming, these new badges and Journeys will set girls up for a lifetime of leadership and success.

In 2017, Girl Scouts of the USA rolled out 30 new badges and two new Journeys exclusively for girls ages 5–18—enhancing the time-tested, one-of-a-kind leadership experience that has prepared countless girls and women to excel in life. The new programming will prepare girls to address some of society's most pressing needs through hands-on learning in cybersecurity, environmental advocacy, mechanical engineering, robotics, computer science, and space exploration.

Robotics badges that teach girls how to program, design, and showcase robots complete the suite of Robotics badges that GSUSA introduced for girls in grades K–5 last year. Now, every

Girl Scout can develop robotics skills and earn badges while she's at it!

The College Knowledge badge for Girl Scouts in grades 11 and 12 is the first badge dedicated to college exploration. By showing girls how to research the admissions process, financial aid, and other key factors, our College Knowledge badge meets a specific need and addresses the life skills girls have told us they're interested in—and that many don't find support for outside Girl Scouts.

Additionally, our recently debuted Think Like an Engineer Journey helps girls understand how engineers address and solve problems. As with all Girl Scout

Leadership Journeys, girls complete hands-on activities and use their newly honed skills to take action in tackling a problem in their communities.

Girls in grades K–5 can now earn badges in:

- **Cybersecurity.** Funded by Palo Alto Networks, our new Cybersecurity badges introduce girls to age-appropriate online safety and privacy principles, how the internet works, and spotting and investigating cybercrime.
- **Space science.** Funded by NASA's Science Mission Directorate and led by the SETI Institute, these badges let girls channel their inner NASA scientist as they learn about objects in space and how astronomers conduct investigations.
- **Mechanical engineering.** Girl Scout Juniors—girls in grades four and five—design paddle boats, cranes, and balloon-powered cars; and learn about buoyancy, potential and kinetic energy, machines, and jet propulsion. Following last year's introduction of Mechanical Engineering badges for girls in grades K–3, the addition of these badges means that ALL Girl Scouts in elementary school now have access to hands-on engineering experiences.

Enhancing Girl Scouts' proven girl-led programming, these new badges and Journeys will set girls up for a lifetime of leadership and success, and prepare them to take action to make the world a better—including greener and more equitable—place for us all.

The new programming for girls in grades 6–12 includes the Think Like a Programmer Journey, funded by Raytheon and providing a strong foundation in computational

**Raytheon** thinking and the framework for Girl Scouts' first-ever national Cyber Challenge, coming in 2019. The programming will prepare girls to pursue careers in fields such as cybersecurity, computer science, and robotics.

Our new Environmental Stewardship badges are funded by the Elliott Wildlife Values Project and expand on Girl Scouts' current Environmental Stewardship badge offerings.



Girls in grades K–12 are encouraged to prepare for outdoor experiences and take

action on environmental issues they care about. These badges are the first to mobilize girls specifically to be environmental advocates who address problems, find solutions, and take the lead to protect the natural world.

## DEBUT OF G.I.R.L. AGENDA POWERED BY GIRL SCOUTS

At G.I.R.L. 2017, Girl Scouts of the USA launched the G.I.R.L. Agenda Powered by Girl Scouts, a nonpartisan initiative to inspire, prepare, and mobilize girls and those who care about them to lead positive change through civic action. The multiyear effort celebrates the Girl Scout legacy of civic engagement, and for the first time ever, GSUSA is sharing free, expert-curated civic engagement resources beyond its 2.6 million members. Included are primers on topics such as speaking up, being open-minded, hearing others' points of view, and getting involved in student council and local politics.

At the G.I.R.L. Agenda booth in the AT&T Hall of Experiences, girls could take action on-site by sending letters to friends and family promoting Girl Scouts' new Daisy Good Neighbor badge!

### GIRL SCOUT TAKES ACTION



Cassie Levesque was just 17 years old when she led a campaign to end child marriage in New Hampshire to earn her Gold Award. Many said she was “just a Girl Scout.” Now, at 19, Cassie’s making history as one of the youngest women elected to New Hampshire’s House of Representatives.

## GIRL SCOUTS: CREATING THE STEM WORKFORCE OF THE FUTURE

In December 2017, Girl Scouts of the USA and Raytheon launched GSUSA’s first national computer science program and Cyber Challenge for middle and high school girls. The program prepares girls in grades 6–12 to pursue computer science careers in fields such as cybersecurity, artificial intelligence, robotics, and data science.

A longtime partner of many Girl Scout councils, Raytheon is the inaugural sponsor of GSUSA’s computational thinking program that will create age-appropriate content and foundational science, technology, engineering, and math (STEM) experiences for girls. This

collaboration will specifically support the development of new content and foundational STEM experiences for middle and high school girls through Girl Scouts’ Think Like a Programmer Journey (currently only available to girls in grades K–5) and will be girl-led—like all Girl Scout programming. Girls will learn key concepts of computer science and complete activities through which they problem-solve with friends while building essential leadership skills. They’ll also have the opportunity to apply what they learn at Girl Scouts’ first-ever Cyber Challenge, where girls will collaboratively apply their new coding skills.

At a time when women account for half the college-educated workforce but constitute only 29% of science and engineering occupations (National Science Foundation, Science and Engineering Indicators, 2016), Girl Scouts is committed to developing female STEM leaders by introducing girls to related careers early on. Providing girls with engaging STEM programming and events, including hands-on learning in computer science and cybersecurity, helps them maintain interest in these subjects at a crucial point in their development. It also supplements what many are already learning in school.

# GETTING MORE GIRLS OUTSIDE MORE OFTEN —THROUGH GIRL SCOUTING

Powering the next generation of women to push boundaries and move mountains.

Girl Scouts of the USA and its partners are working together to reach an important goal: get more girls outside more often.

Through outdoor program content that volunteers can access via GSUSA's Volunteer Toolkit, a fully-customizable digital planning tool that helps volunteers plan and prepare meetings and activities, and the piloting of a partnership program with the Student Conservation Association, five Girl Scout councils are offering girls sustainable environmental internship programs.

The councils participating in the pilot—Girl Scouts of Alaska, Girl Scouts–Arizona Cactus-Pine, Girl Scouts of Greater

New York, Girl Scouts of Southeastern Michigan, and Girl Scouts Western Pennsylvania—have used the grant funds for a range of pursuits, including providing basic outdoor skills training for volunteers and organizing stargazing events for girls with help from NASA.

Together, the Richard King Mellon Foundation, Student Conservation Association, NASA, and Girl Scouts of the USA elevate outdoor (and outdoor conservation) activities, enhancing the Girl Scout experience for all.

In addition, powering the next generation of women who push boundaries and move mountains, we're teaming up with the North Face to develop 12 new Outdoor Adventure badges, with programming ranging from mountaineering and climbing to backpacking, hiking, and trail running. And with the North Face's support, Girl Scouts will introduce bold new programming that embodies the shared mission of both organizations—to provide girls, regardless of socioeconomic status, with outdoor experiences that enhance their leadership skills and confidence and encourage them to seek challenges.

These dozen new badges, which will debut over the next two years, will teach girls in virtually every U.S. zip code about the benefits of exploration as they take healthy risks, overcome fears, and revel in the beauty of the natural world. The North Face is also lending its expertise in design and tapping its network of subject matter experts to help us develop the badge activities.

## THE GET OUT CHALLENGE

Working with Arizona State Parks and Trails, the Girl Scouts–Arizona Cactus-Pine council created a six-week-long competition—the Get Out Challenge—awarding points for participation in outdoor activities. Girl Scout troops, individual girls, and families competed for the title of “most adventurous,” and Girl Scouts earned Outdoor badges and completed Journeys and service projects.

## TAKE ACTION FRIDAYS

Girl Scout Seniors and Ambassadors from the Girl Scouts of Greater New York council had the opportunity, through Take Action Fridays, to work with younger girls on environmental service projects relevant to their communities. Among other things, the girls created a birdhouse for their local park and built a green space that stops runoff from a nearby river, in the process learning how they can improve the environment through hands-on experiences.



## GIRL SCOUTS KICKS OFF NEXT CENTURY OF FEMALE ENTREPRENEURS

In 2018, Girl Scouts entered its second century of Girl Scouts selling cookies! Given that more than half (57%) of Girl Scout alums in business fields credit the Girl Scout Cookie Program with helping them develop skills they use today—including money management, goal setting, and public speaking—selling Girl Scout Cookies has helped millions of female entrepreneurs over the past 100 years spark their careers.

During Girl Scout Cookie season, participating Girl Scouts across the country show their G.I.R.L.

(Go-getter, Innovator, Risk-taker, Leader)™ spirit as they sell delicious cookies, building entrepreneurial skills along the way that are imperative to leadership and success. And the funds from every cookie purchase power amazing experiences for girls year-round, like camping adventures, global travel, and service projects that benefit communities. That's because all of the net revenue from cookie sales—100% of it—stays within a Girl Scout council's local area to benefit girls.

These days, girls sell cookies door-to-door and at booths, as well as through the Digital Cookie® platform, an innovative and educational web-based addition to the cookie program through which girls run their Girl Scout Cookie businesses online. Now in its fourth year, Digital Cookie continues to keep Girl Scout programming current and relevant to today's girls by providing them with valuable business and science, technology, engineering, and math (STEM) skills that prepare them for 21st-century leadership.

## PREPARING THE NEXT GENERATION OF GIRL SCOUTS

Thanks to the success of the Dianne Belk and Lawrence Calder Girl Scout Movement-Wide Planned Giving Challenge (“Belk-Calder Challenge”), Girl Scouts of the USA and 102 Girl Scout councils received irrevocable planned gifts (made through a donor's will or estate plan) from the couple totaling \$1.2 million. The projected financial impact of the Belk Calder Challenge exceeds \$30 million in planned gifts to councils and GSUSA. More than 800 new planned giving donors were pinned as members of the Juliette Gordon Low Society as a result of the challenge, bringing the total of members to more than 4,000.

The Belk Calder Challenge enabled Girl Scout councils and USA Girl Scouts Overseas (“USAGSO” brings Girl Scouting to the daughters of military, foreign service, and American expat families around the world) to maximize the impact of the challenge. Councils, GSUSA and USAGSO secured 834 new planned gifts during the



challenge period, while simultaneously educating their board members and volunteers about planned giving. The Belk Calder Challenge constituted the first known gift from an individual that was specifically directed to all Girl Scout councils, GSUSA and USAGSO.

This fall, we opened the doors to our premier Girl Scout store and experience at Girl Scouts of the USA headquarters—420 Fifth Avenue in New York City. Beyond serving as a one-stop shop for Girl Scout uniforms, badges, and a number of other great items that let customers showcase their Girl Scout pride, the space is an awesome place for G.I.R.L.s from across the country to meet, trade stories, and possibly even form lifelong friendships.

### GIRL SCOUTS JOINS MACY'S THANKSGIVING DAY PARADE

Girl Scouts of the USA's "Building a Better World" float returned to the 91st Annual Macy's Thanksgiving Day Parade®. Grammy Award–nominated singer-songwriter Andra Day performed on the float, singing her moving anthem, "Stand Up for Something," from the film *Marshall*. Day was accompanied by Grammy and Academy Award–winning artist and actor Common, who co-wrote and is featured in the song. The Girl Scout float design reflects a century of Girl Scout traditions and highlights today's girls as capable of making great changes to benefit society. This year an audience of more than 50 million saw our float, which featured two dozen giant Girl Scout badges representing everything from science, technology, engineering, and math (STEM) and the outdoors to financial literacy and entrepreneurship, as well as the Gold Award, Girl Scouts' highest award.

### THREE GIRL SCOUTS + THREE DAYS IN THE "EQUALITY LOUNGE" AT DAVOS

USA Girl Scouts Overseas (USAGSO) participated in the famed World Economic Forum in Davos, Switzerland, gathering with close to 100 thought leaders and influencers to discuss how to take equality from an ideal to a reality.

Geneva-based Girl Scouts Freya, Melissa, and Isahni attended the Equality Lounge hosted by The Female Quotient, giving them an incredible learning opportunity and an important seat at the leadership table. USA Girl Scouts Overseas brings Girl Scouting to the daughters of military, foreign service, and American expat families around the world, serving thousands of American girls who want to enjoy the same excitement, fun, and adventure as their stateside Girl Scout sisters. USAGSO also provides girls with access to amazing opportunities like the Davos forum.

## HIGHLIGHTS

### UNVEILING A NEW SITE-USE PLAN FOR THE BIRTHPLACE OF GIRL SCOUTING

Since 1956, Girl Scouts has hosted more than a million girls at the Juliette Gordon Low Birthplace in Savannah, Georgia—but over the years, it’s become increasingly difficult to meet the needs of all visitors to Juliette’s former home. So to address safety, accessibility, and sustainability issues, in 2018 a new site-use plan was unveiled, which will enable us to continue serving and inspiring visitors for generations to come.

The plan identifies multiple opportunities to improve birthplace facilities. Renovations to the outdoor space will create a space for troops to conduct

pinning ceremonies and participate in programming, while reorientation of ticketing, reception, and retail space will enhance the visitor experience. These changes, which will also feature an entrance along Bull Street that will provide better visibility and easier access to the space, will make the back entrance and the second floor program spaces accessible for the first time. The reimagined spaces, reflecting Girl Scouts’ commitment to accessibility, will make Juliette’s home a welcoming place for the community and a true destination for Savannah visitors.

### FAST COMPANY NAMES SYLVIA ACEVEDO ONE OF THE 100 MOST CREATIVE PEOPLE IN BUSINESS

In May 2018, Fast Company released its “100 Most Creative People in Business” list, and Girl Scouts of the USA CEO Sylvia Acevedo is on it! Sylvia was recognized for her “vision and creativity, including debuting forward-thinking programming in STEM and the outdoors and critical initiatives such as the G.I.R.L. Agenda, which aims to inspire, prepare, and mobilize girls to lead through civic action; and the Girl Scout Network on LinkedIn, which invites the organization’s more than 50 million alums to connect to enhance their career development.”

This recognition is an incredible honor for the Girl Scout organization, and a testament to Girl Scouts’ relevance not only among girls and their families but also with regard to the conversations happening nationwide about girls’ leadership. All of Sylvia’s work at the national level is in service to our mission and our commitment to building the G.I.R.L.s—the go-getters, innovators, risk-takers, and leaders—who are changing, and will continue to change, the world.

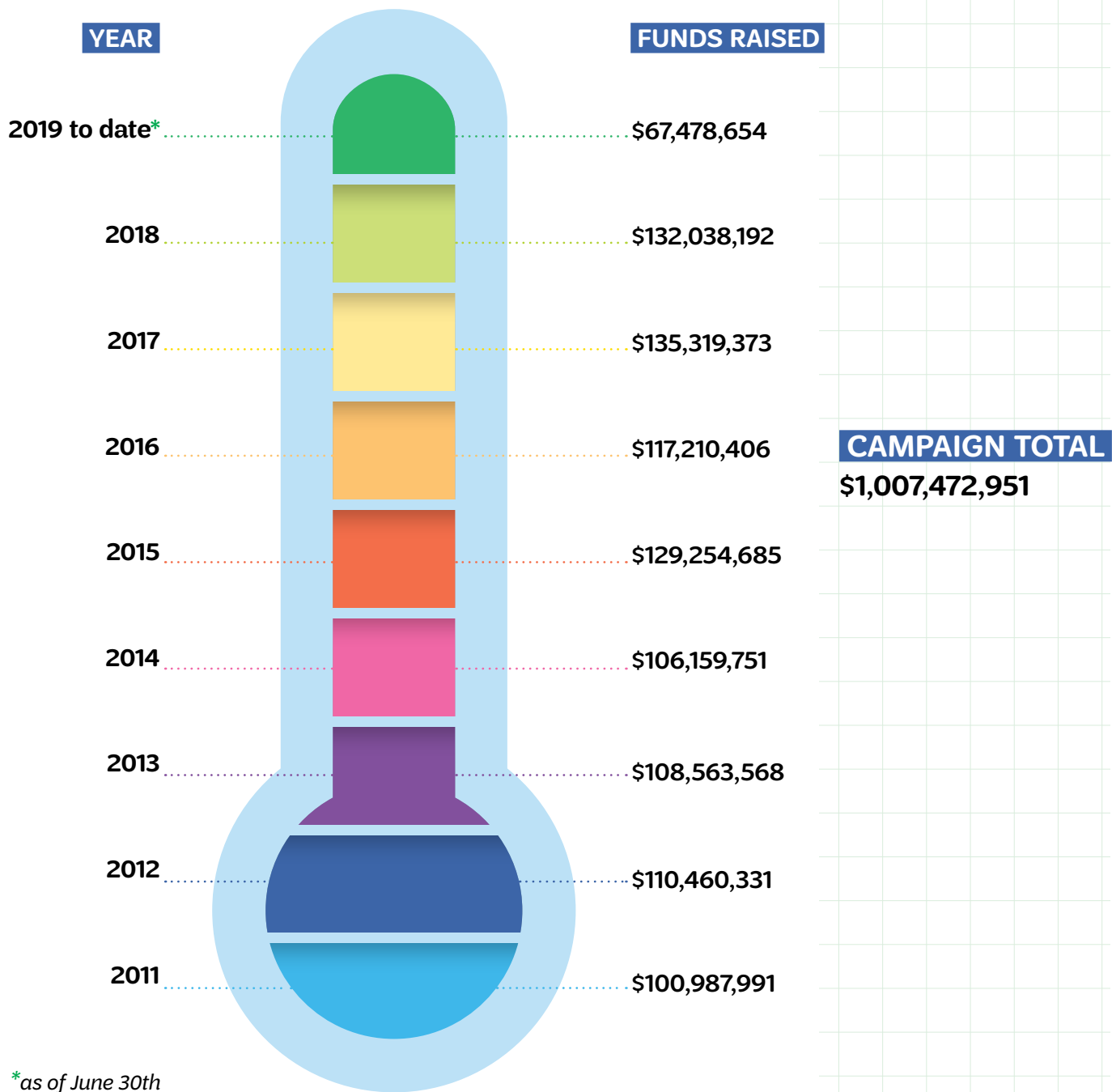

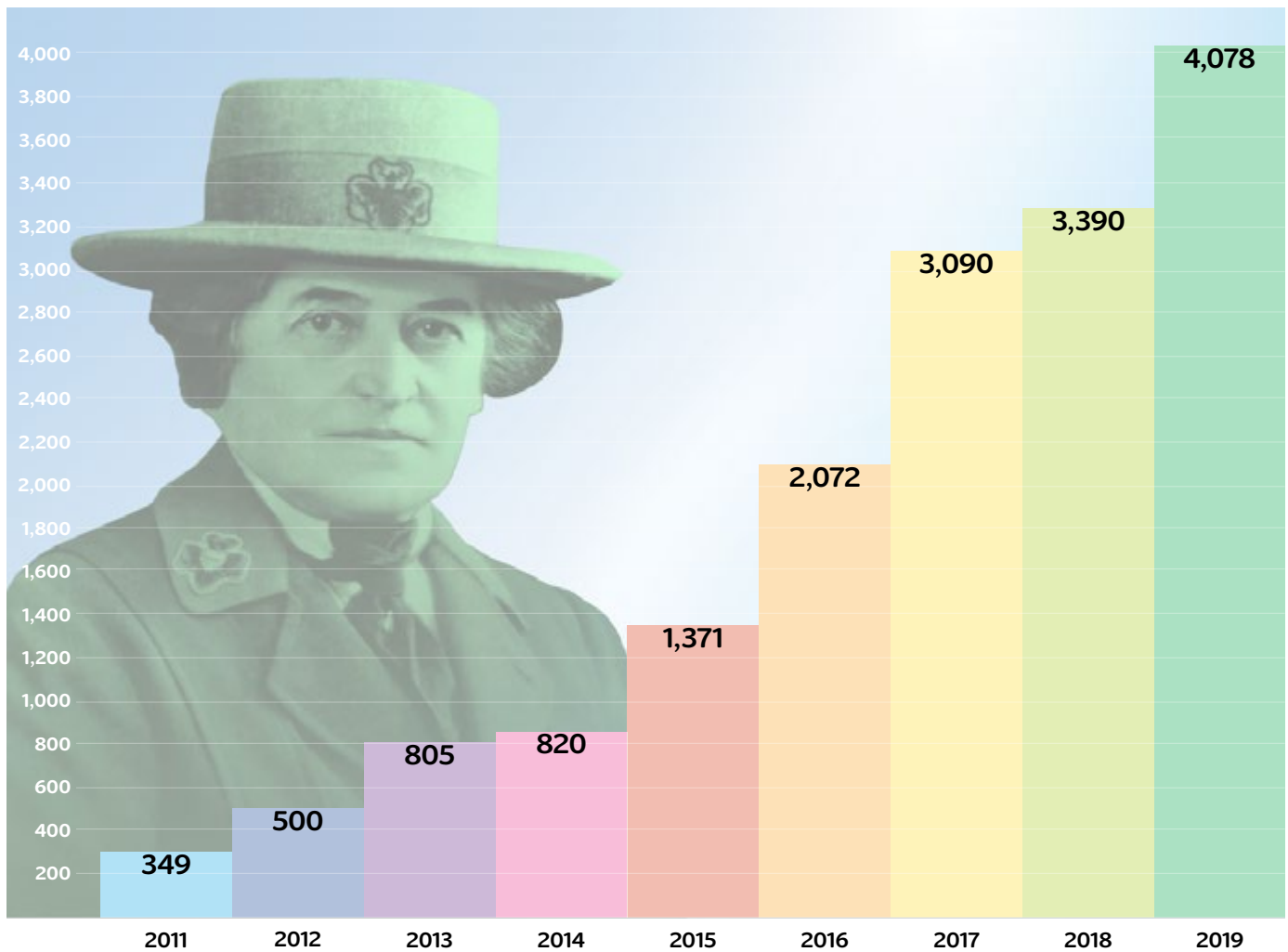


# TOGETHER THERE CAMPAIGN RESULTS
